

## West River Valley Supportive Living

#### Located at 461 Grafton Rd, Townshend, VT 05353

- Located conveniently just down the road from Grace Cottage Hospital
- Located next door to the West River Valley Senior Housing Independent Living
- Attached to the West River Valley Assisted Living Facility

West River Valley Supportive Living is both affordable housing and a supportive living facility. Due to its unique business model, there are two parts to an applicant's eligibility.

- 1.) Affordable housing requirements such as meeting the tenant selection criteria and income/financial requirements as well as suitability checks.
  - Must be 62 years of age or disabled to qualify.
  - Must meet income limit levels
  - Must pass suitability checks including criminal record, landlord references, credit checks and character references.
- 2.) State of Vermont Assisted and Residential Care regulations require that each applicant meet both the financial and clinical requirements as well.
  - Must be able to show proof of financial resources to pay for rent and supportive living services.
  - Must meet supportive living level of care.

# West River Valley Supportive Living 2024 Rate Sheet

1. Rent (room): Rent is charged monthly. The rent charge includes heat, hot water, electricity (excluding an additional fee for those residents who have air conditioners) and trash pick-up.

Rent charges are based on income and increase yearly:

- 1 Bedroom at or below 50% Windham County median family income = \$850
- 1 Bedroom at or below 60% Windham County median family income = \$950
- 1 Bedroom above 60% Windham County median family income = \$1200
- 2. Security Deposit: One month's security deposit is due along with first month's rent upon admission.

## Rent is due to Stewart Property Management (SPM) by the 1st of the month:

- Sign up for monthly automatic direct payments (ACH)
- Pay by check: Please make your rent check out to: West River Supportive LP
- Mail your check to: SPM Property Management, PO Box 10540, Bedford, NH 03110

## Rent is not covered by Medicare, Medicaid, or secondary insurance.

**3. One time admission fee:** All successful applicants who choose assisted living programming are charged an admission fee at the time they are offered and accept an agreement to rent an apartment = \$1650.

- **4. Supportive Services Fee**: This is a daily fee for supportive services, which includes participation in all activity programming, health care emergency response pendant, and transportation to monthly appointments = \$32 a day.
- **5. Elective Supportive Services available for purchase:** Residents on the Supportive Living program may elect one or more of the below services. These services are billed monthly.
  - Full dining plan (breakfast, dinner, and supper meals) = \$500 per month
  - 30-day dining plan (choose one meal a day to attend) = \$391 per month
  - Cleaning service (weekly apartment cleaning) = \$ 139 per month
  - Laundry service (2 loads of laundry weekly) = \$81 per month
  - Cleaning & Laundry (discounted if you buy both) = \$ 206 per month

#### Supportive Service Fees and Electives are paid to Valley Cares.

These fees and are due by the 5<sup>th</sup> of the month. There are three ways to pay your fees.

- Place your monthly check in the metal box located on the wall in the dining room.
